Case Example: Global Investigation

A la carte Model

- Supported a multinational company with a global investigation, collecting data from nine countries in 24 languages.

Case Example: HSR Second Request

V3LOCITY Model

- Supported a publicly traded, Fortune 500 company seeking a \$400+ million acquisition.

- Leveraged workflows and analytics to reduce document population to just 11% of the original 2.5 million documents.
